

How to get proof of your church's group exemption



To apply for the free Canva Pro account for nonprofits, you need a document proving you are part of the UMC's group exemption. Here are the instructions to follow to get this document.

Step 1

Go to <https://www.umgroupruling.org/>. Enter your church's EIN, the IRS's Employer Identification Number for your church. This can be found on your payroll records. Choose Church as your type of organization. Check that you are not a robot, and hit submit.

Please complete the form below to receive a Certificate of Inclusion letter verifying your organization's tax-exempt status as a group ruling subordinate. You should complete this form if 1) your organization is applying for inclusion for the first time or 2) you are in need of an updated inclusion letter for your organization. This website was designed so that you can easily request a letter, and submit any updates needed, at any time.

As you see below, your organization's name and address have populated according to how they are currently listed in our Chronicles database. This is how they will appear in your letter if no changes are requested. To request changes to the name and/or address, you will first need to select the "I need to make changes" button below the address. When this button is selected, the name and address fields will become editable and you will be able to edit the information as needed. Your organization's legal name and current address should be listed on your group ruling letter.

Additionally, you will see options to have your organization listed on GuideStar and the IRS Exempt Organization Business Master File ("EO BMF"). If you would like additional information on either of these options, please use the associated links.

When all fields are complete, please click the Submit button to proceed. If no changes to the organization's information were requested, you will be taken to the confirmation page where you can obtain your tax packet by viewing it in the browser, downloading it to your local device, and/or emailing it to the contact email listed on the form. Your tax packet will include three documents: 1) your group ruling certification letter, 2) the 1974 IRS letter to GCFA granting the group ruling, and 3) IRS Publication 1974 containing general information about group exemptions. We recommend that you keep all documents together when sharing with charitable organizations.

In particular, as stated in the GroupRuling determination letter issued to The United Methodist Church by the Internal Revenue Service ("IRS"), this affiliated organization is exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code.

This certification letter is issued by the General Council on Finance and Administration of The United Methodist Church ("GCFA"), the central organization for the UMC Group Ruling. As the central organization, GCFA has been granted the authority by the IRS to determine which organizations are included in the UMC Group Ruling. (The IRS Group Exemption Number ("GEN") for the UMC Group Ruling is 2573.) Thus, this certification letter, together with the enclosed copy of the IRS Group Ruling determination letter, serves to verify the tax-exempt status of this affiliated organization.
